Happy New Year to everyone. We wish you all many positive blessings and encourage everyone to be thankful for the blessings already received.

Paskwa Pit Stop Gas and Convenience Store has proudly served our community and surrounding areas for nearly 24 years. We first opened in May 2002 in the basement of the Pasqua Band Office and have continued to grow while providing friendly, reliable service to our customers. Although we are a small store, we remain committed to being open and available to our community. The only day we intentionally close is Christmas Day, so our staff can spend time with their families.



Our regular business hours are 8:00 a.m. to 10:00 p.m. on weekdays, and 9:00 a.m. to 9:00 p.m. on weekends and holidays.

In 2005, we opened a small Post Office with 150 mailboxes. We pick up mail and parcels from the Fort Qu'Appelle Post Office and return them to Pasqua for sorting into the appropriate boxes. This service was created for the convenience of community members who requested postal boxes.

Currently, we employ six full-time staff, including a General Manager and Assistant Manager, as well as four to five part-time and casual employees. The General Manager and Assistant Manager rotate weekends to be on call for emergencies.

Like any business, we face challenges. These include staff turnover, mechanical issues, rising supplier costs, and purchase order management. Staff turnover can be costly, as training requires time and commitment, and it is important to find dependable, responsible, and trustworthy individuals. When supplier prices increase, we must adjust our prices accordingly. Purchase orders also present challenges, as they are commitments that must be honored to meet financial obligations.

Despite these challenges, solutions can always be found through experience, teamwork, and knowing where to seek support. One significant challenge occurred when Paskwa Pit Stop became incorporated, requiring all supplier accounts to be closed and reopened, involving extensive legal and administrative paperwork. Through dedication and perseverance, we continue to move forward and serve our community with pride. ~ Cynthia Missens
